Standard Limited Carry-In Factory Warranty

What is covered and for how long?

The warranty period commences upon date of purchase by the first consumer purchaser and continuing for the following specified period of time after that date:

Additional Warranty Information

All equipment purchase above has a standard "Carry In" Factory Warranty, against any Manufactures defects as well against any product malfunctions stipulated within its warranty period.

The warranty runs from date you purchase the product. The "product" includes any accessories, Forefront Presentation Media supplied with it, except for items which are consumables.

What is not covered?

This Limited Carry-In Warranty is conditioned upon proper use if the Product by Purchaser.

This Limited Carry-In Factory Warranty does not cover:

- a) Externally caused damage
- b) Use outside specification (as defined by the product manufacturer, whose decision it is whether the product is used outside its specification)
- c) Accessories, parts or consumables which are not Original Manufacturer branded or approved OR modifications made to the product as originally supplied by the manufacturer is identified

What are Parrot Products' obligations?

During the applicable warranty period, provided the Product is returned in accordance with the terms of the Limited Carry-In Warranty, Parrot Products Pty Ltd will immediately swop out the unit if the problem cannot be resolved within 3 days. This Limited Warranty is extended to the Purchaser and is not transferable or assignable to any other person or entity.

What must you do to obtain warranty service?

To obtain service under this Limited Carry-In Warranty, you must return the Product to an authorized service facility (Parrot Products Branch) in an adequate container for shipping, accompanied by the sales receipt or comparable proof of sale showing the original date of purchase by the first consumer purchaser, the serial number of the Product and the seller's name and address.

You shall be responsible for any and all freight costs associated with sending in your Product for service.
